The applicant states that the tree "impedes sight lines of new balcony."

The applicant has offered the following for mitigation:

- 1. Replant smaller shrub;
- 2. Replant tree at Bienville Square or other downtown park;
- 3. Sponsor \$750 worth of beautification projects in downtown.


The tree is located in front of a two-story building undergoing renovation, including the addition of a balcony to the facade of the building nearest the tree. The tree is in a tree grate located in the sidewalk.

The tree was planted as part of a tree planting plan developed for the downtown area. The maple trees selected for the planting program do not appear to be well suited to very urban street tree situations, as many of the trees originally planted have shown varying levels of decline and have been removed elsewhere downtown. Many trees planted in extreme urban conditions do not have a long life, regardless of the species.

## **RECOMMENDATION**


If considered for approval, staff recommends the following conditions:


- 1. Replacement tree species and size to be approved by the Urban Forester, or donation of two trees to the Tree Bank, for a total of \$ 400.00;
- 2. Tree removal permit be issued to a certified arborist who is licensed and bonded to work in the City of Mobile; and
- 3. All work in the right-of-way, including tree removal and tree replanting, to be coordinated with Urban Forestry and the Permitting/Right-of-Way Division.


