Recommendation:If the pruning work is approved, the work should be subject to the following conditions:

1. Work to comply with ANSI A300 Pruning Standard; and
2. Work to be coordinated with the appropriate utility provider(s).

If the removal work is approved, the work should be subject to the following conditions:

1. Obtaining of permit for any required work in the Right-of-Way from Right-of-Way Permitting Division;
2. Work to be coordinated with the appropriate utility provider(s); and
3. Provision of replacement trees, to be coordinated with Urban Forestry; or
4. Donation of trees to the Mobile Tree Commission tree bank, at a cost of \$ 200.00 per tree.
