LOCATION: Claridge Road sidewalk repair

TREE HEALTH:

SITUATION: Staff would like to request permission to approve work done within the critical root zone as needed.

STAFF RECOMMENDATION: Staff would like to recommend approval of this application that all work will be done as per Mobile Tree Commission specifications. This project is identical to sidewalk repair that was done in the midtown area within the last three years.

SPECIFICATIONS

1. THE CONTRACTOR SHALL MAINTAIN ACCESS TO EXISTING DRIVEWAYS THROUGHOUT THE CONTRACT TIME PERIOD TO THE EXTENT POSSIBLE. THE CONTRACTOR SHALL CHECK THE PROJECT AT THE END OF EACH WORK DAY AND PERIODS OF INCLEMENT WEATHER, AND TAKE WHATEVER ACTIONS NECESSARY TO INSURE THAT THE AREA RESIDENTS HAVE ACCESS TO THEIR PROPERTY. NO SEPARATE PAYMENT SHALL BE MADE FOR THE ABOVE REFERENCED WORK, AND THE COST SHALL BE INCLUDED IN THE OVERALL CONTRACT PRICE.

2. CITY OF MOBILE URBAN FORESTRY REQUIREMENTS: VIOLATIONS OF THE FOLLOWING REQUIREMENTS WILL MANDATE A TICKET AND A SHUTDOWN OF THE PROJECT. THE FOLLOWING ITEMS SHALL BE CONSIDERED SUBSIDIARY TO ITEM NO. 618.

A. BARRIER FENCING IS REQUIRED AROUND TREES TO BE PRESERVED WHEN CONSTRUCTION WORK IS BEING DONE IN ITS VICINITY. (FENCING SHALL NOT BE REQUIRED WHERE THE EXISTING SIDEWALK AND TREE OR ITS ROOTS ARE IN DIRECT CONTACT.)

B. ANY FILL MATERIAL (TOP SOIL, CRUSHED STONE, ETC.) PLACED ON OR AROUND EXPOSED TREE ROOTS OUTSIDE OF THE SIDEWALK WILL REQUIRE THE URBAN FORESTER OR HIS DEPARTMENT REPRESENTATIVE'S APPROVAL AND SHALL BE PAID UNDER THE CORRESPONDING ITEM NUMBER.

C. ALL EXCAVATION THAT COULD CONTACT A TREE OR ITS ROOTS SHALL BE HAND DUG.

D. ALL ROOTS GREATER THAN 2" ON TREES TO BE PRESERVED THAT REQUIRE CUTTING SHALL REQUIRE APPROVAL FROM THE URBAN FORESTER OR HIS REPRESENTATIVE.

E. ALL ROOTS ON TREES TO BE PRESERVED THAT REQUIRE CUTTING SHALL BE CLEAN CUT WITH A SHARP CUTTING TOOL AND SHALL REQUIRE APPROVAL OF THE URBAN FORESTER.

F. NO VEHICLE, EQUIPMENT, OR CONSTRUCTION MATERIALS SHALL BE STORED OR PLACED ON ANY ROOTS OF ANY TREE TO BE PRESERVED OR ITS TRUNK. THE CONTRACTOR SHALL PROTECT ALL ROOTS, TRUNKS AND LIMBS OF ANY TREE TO BE PRESERVED TO PROHIBIT ANY DAMAGE TO THE TREE.

G. NO HAZAROUS OR HARMFUL MATERIAL SHALL BE STORED AS TO HARM ANY VEGETATIVE SPECIES IN THE CITY'S RIGHT-OF-WAY.

H. NO LIMBS SHALL BE REMOVED FROM THE TREES TO BE PRESERVED EXCEPT BY PERMIT FROM THE URBAN FORESTER.

I. ANY CONSTRUCTION ACTIVITY THAT WOULD AFFECT THE TREES TO BE PRESERVED ON THIS PROJECT SHALL REQUIRE THE APPROVAL OF THE URBAN FORESTER.
