REQUEST

Request by the Village of Springhill that the Mobile Tree Commission consider helping fund the purchase and installation of eighteen (18) Live Oak trees to be planted within the boundaries of the Village of Spring Hill.

ANALYSIS

The Live Oaks will be planted on public rights-of-way around the parameter of the roundabout on North McGregor Avenue and Museum Drive as shown on the attached landscape plan. The Live Oak trees are in thirty (30) gallon containers, and will be spaced approximately thirty (30) feet apart in accordance with The Village of Spring Hill Master Plan (The Blueprint for Spring Hill).

Each Live Oak tree costs \$100.00, exclusive of labor and planting. The Village of Springhill is requesting a \$1,000.00 donation from the Mobile Tree Commission to help offset the costs of this project.


To Whom It May Concern:

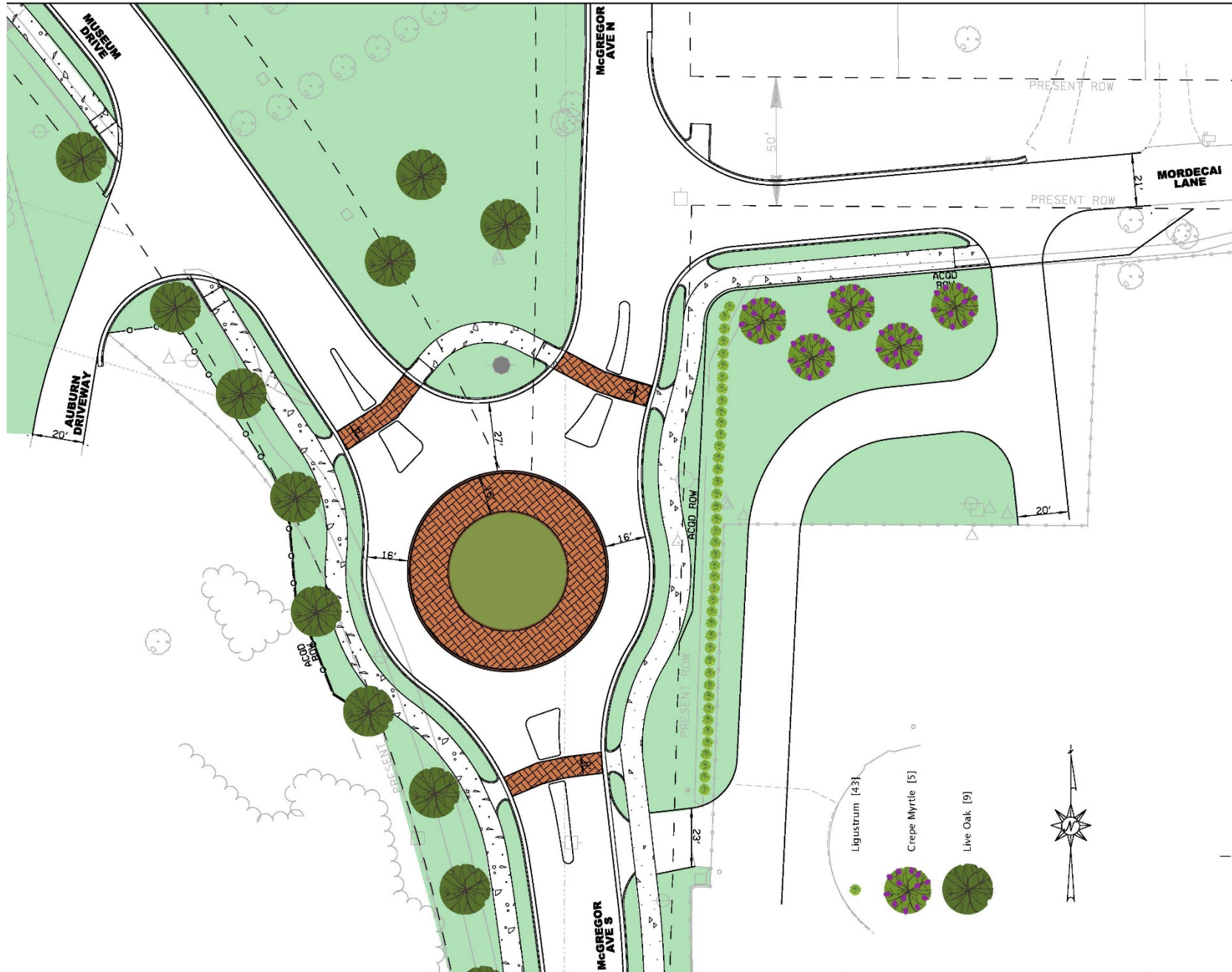
