Engineering Comments: Must comply with the Mobile County Flood Damage Prevention Ordinance. Development shall be designed to comply with the storm water detention and drainage facility requirements of the City of Mobile storm water and flood control ordinances, and requiring submission of certification from a licensed engineer certifying that the design complies with the storm water detention and drainage facility requirements of the City of Mobile storm water and flood control ordinances prior to the issuance of any permits.

<u>Fire-Rescue Department Comments:</u> All projects within the City Limits of Mobile shall comply with the requirements of the City of Mobile Fire Code Ordinance (2012 International Fire Code). Projects outside the City Limits of Mobile, yet within the Planning Commission Jurisdiction fall under the State or County Fire Code (2012 IFC).

MAWSS Comments: No comments.

The preliminary plat illustrates the proposed 2-lot, $1.7\pm$ acre subdivision which is located on the South side of Airport Boulevard, $675'\pm$ East of Snow Road South. The site is within the Planning Jurisdiction and the applicant states that the subdivision is served by public water and individual septic tanks. The purpose of this application is to relocate an interior lot line between two (2) legal lots of record.

The proposed lots front Airport Boulevard, a major street on the Major Street Plan. As a major street, Airport Boulevard requires a 100' right-of-way width. The right-of-way width is depicted as "varies" on the preliminary plat. The distance from the centerline is illustrated and should be retained on the Final Plat, if approved.

The preliminary plat illustrates a 25' minimum building setback line along Airport Boulevard. If approved, the 25' minimum building setback along Airport Boulevard should be retained on the Final Plat. The preliminary plat also illustrates a 20' building setback to the rear to the rear of the proposed Lot 2. If approved, the 20' building setback should be retained on the Final Plat.

In accordance with Section V.D.2. of the Subdivision Regulations, the proposed lots each exceed the 15,000 square foot minimum lot size requirement for lots served by public water and individual septic systems. The lot size information for each lot is depicted in both square feet and in acres on the preliminary plat and should be retained on the Final Plat, if approved.

As a means of access management, a note should be placed on the Final Plat, if approved, stating that Lot 1 and Lot 2 are limited to one curb cut each to Airport Boulevard, with the size, design and location of the curb cut to be approved by Mobile County Engineering and conform to AASHTO standards.


It should be noted that there are easements present on the both the proposed Lot 1 and Lot 2. If approved, a note should be placed on the Final Plat stating that no structure shall be erected in any easement.


This site is located in the County; therefore, any lots which are developed commercially and adjoin residentially-developed property must provide a buffer, in compliance with Section V.A.8. of the Subdivision Regulations. A note should be placed on the Final Plat, if approved.

Based upon the preceding, this application is recommended for Tentative Approval, subject to the following conditions:

- 1) Retention of the minimum right-of-way widths to Airport Boulevard;
- 2) Retention of 25' minimum building setback line along Airport Boulevard;
- 3) Retention of 20' minimum building setback line along the rear of Lot 2;
- 4) Retention of the lot size information in both square and in acres on the Final Plat, adjusted for dedication;
- 5) Placement of a note on the Final Plat stating that Lot 1 and Lot 2 are limited to one curb cut each to Airport Boulevard, with the size, design and location of the curb-cut to be approved by Mobile County Engineering and conform to AASHTO standards;
- 6) Placement of a note on the Final Plat stating that any lots which are developed commercially and adjoin residentially developed property must provide a buffer, in compliance with Section V.A.8. of the Subdivision Regulations;
- 7) Placement of a note on the Final Plat stating that no structures shall be erected in any easement;
- 8) Compliance with Engineering Comments and placement as a note on the Final Plat: (Must comply with the Mobile County Flood Damage Prevention Ordinance. Development shall be designed to comply with the storm water detention and drainage facility requirements of the City of Mobile storm water and flood control ordinances, and requiring submission of certification from a licensed engineer certifying that the design complies with the storm water detention and drainage facility requirements of the City of Mobile storm water and flood control ordinances prior to the issuance of any permits.); and
- 9) Compliance with Fire Comment: (All projects within the City Limits of Mobile shall comply with the requirements of the City of Mobile Fire Code Ordinance (2012 International Fire Code). Projects outside the City Limits of Mobile, yet within the Planning Commission Jurisdiction fall under the State or County Fire Code (2012 IFC).


LOCATOR MAP

LOCATOR ZONING MAP







ENVIRONMENTAL LOCATOR MAP


